BID DOCUMENTS AND TERMS & CONDITIONS:

1. MODE OF SUBMISSION OF BID

- 1.1 Bids should be submitted in the prescribed form obtainable from the above address.
- 1.2 The bids should be submitted in sealed cover addressed to **Managing Director, WBIDFC LTD, KOLKATA**
- 1.3 Sealed bid documents should be dropped in the drop box kept in the Office of the Corporation at 24 HEMANTA BASU SARANI, MANGALAM BUILDING, BLOCK A 1ST FLOOR, KOLKATA-700001 prior to the closing date and time of the bid. Once the bid is submitted no withdrawal will be allowed.
- 1.4 The bid documents sent through courier or post, should reach the above address sufficiently in advance of the closing date and time of the bid. No bid will be received after 3pm on 19.08.2016
- 1.5 The bid documents submitted in any other form like Telex / Fax /Tele Fax /Telephones /E- mail will not be considered.
- 1.6 Incomplete bid or bids submitted with any condition or with condition at variance with the terms and conditions of the bid document are liable to be rejected.
- 1.7 In event of office remaining closed on the date of opening of the bid for any unforeseen reason, the bid shall be received and opened on the next working date at the stipulated time
- 1.8 Bidders should sign on all the pages of the bid document.

2. QUALITY&QUANTITY OF MATERIALS

- 2.1. The goods are offered purely as scrap materials in lot and on 'AS IS WHERE IS ' basis The scrap of IRON ROD are being sold on LOT basis. The entire material kept in the lot will have to be lifted by the selected Bidder so as to clear the total site at a time. Pick and choose method of collection is strictly prohibited.
- 2.2. The interested bidders should thoroughly satisfy himself about the nature, conditions quantity, and quality of the materials at the time of his inspection. No complain in this respect will be entertained in future

3. RESERVE PRICE

- 3.1 Reserve Price of the lot of scrap materials is fixed at Rs. 65000 /-(Rupees Sixty Five thousand) Only. No bid below the reserve price will be accepted.

4. EARNEST MONEY

- 4.1 Each bidder will have to pay Earnest Money of Rs 3,000/-(Rupees Three thousand only) in the shape of Account Payee demand Draft, Fixed Deposit or Banker's cheque from any of the scheduled banks, drawn in favour of WBIDFC LTD , Payable at KOLKATA
- 4.2 Each bid must be accompanied by Earnest Money for an amount as specified in the document. Bid without any Earnest Money of specified amount will be rejected.
- 4.3 No interest will be paid on Earnest Money deposit amount.

4.4 In case of unsuccessful bidders, the Earnest money deposit will be refunded within 7(Seven) working days from the date of opening of the bid.

4.5 The same will be refunded without any interest to the successful bidder only after satisfactory execution of the work in all respect and fulfillment of all obligations i.e. after lifting of all the materials within the stipulated period from the site and cleaning the site as per instructions.

5 INSPECTION OF SCRAP MATERIALS

5.1 The scrap materials shall be kept open for inspection. The interested bidders may inspect the materials on 36A HEMANTA BASU SARANI, KOLKATA 700001 on the specified date and after obtaining necessary permission.

5.2 The prospective bidders may contact Acting Estate Manager, WBIDFC LTD, KOLKATA-700001 for their inspection. Only one person from each bidder will be permitted for inspection of the item. The person should produce proof of documentary evidence like authorization letter in their letter pad, along with any of the identity proof such as visiting card, identification card, driving license, passport, PAN card etc. before inspection. The bidder will be permitted to inspect the items only once and they will not be entertained again.

6. ACCEPTANCE OF BID

6.1 The bidder who submits the highest financial bid without any condition and whose bid is found to be as per terms and conditions of this bid document shall be declared as the selected bidder provided the said financial bid is more than the reserve price fixed and mentioned herein.

6.2 The selected bidder will be intimated about the acceptance of his offer in writing within seven days of the finalisation of bid.

6.3 The selected bidder should return the duplicate copy of the intimation letter regarding acceptance of his offer by the corporation duly signed and stamped as a token of acceptance within 5(five) days of the receipt of such letter.

7 PAYMENT TERMS

7.1 The selected bidder will have to pay the total bid value within **SEVEN** days from the date of receipt of the intimation letter regarding acceptance of his bid by demand draft/pay order/bankers' cheque in favour of WBIDFC LTD payable at KOLKATA.

7.2 No extension of time in making payment of bid value will be given.

7.3 If the successful bidders fail to deposit the total bid value within the scheduled time and in the manner provided here in, the bid submitted by the selected bidder shall stand cancelled and the Earnest Money Deposit shall stand forfeited.

8. LIFTING OF MATERIALS

8.1. After receipt of full payment from the selected bidder lifting order for lifting materials will be issued by the Corporation.

8.2. Entire quantity has to be lifted positively within 07 days of issue of lifting order. Any delay in lifting of materials beyond the specified period may attract ground rent as per rate fixed by WBIDFC LTD or may lead to termination of contract, as decided by WBIDFC LTD.
