General Terms & Conditions

3. The Bids will be evaluated on the basis of price quoted by the Vendors fulfilling the eligibility criteria and the eligible Vendor quoting L-1 price will be awarded with the job, subject to compliance with other applicable terms & conditions.

The original documents of EMD (Earnest Money Deposit) should be furnished before the Tender Inviting Authority, when asked to do so during evaluation of tenders and the L1 bidder shall submit the original EMD and also have to furnish all relevant documents in original to the Tender Inviting Authority before issuance of LOI. The scan copy of the EMD is to be uploaded with statutory documents.

4. Submission of Tender:- a) **Technical Bid (Part – I) vide Annexure – I and Financial Bid (Part – II) vide Annexure – II** both will have to be submitted online concurrently after duly signed and sealed in the portal <https://wbtenders.gov.in> as per time schedule stated herein under. Time will be recorded as per service clock; b) The financial Bid of the prospective bidders will be opened only if the bidders qualify in the Technical Bid. The decision of the Tender Inviting Authority will be final and binding to all challenge against such decision will not be entertained.

6. Eligibility Criteria of the bidders:

a) The bidders should possess the credential of execution of similar nature of work in Government / Government under taking / Autonomous Bodies / Statutory bodies and local bodies of value not less than 40% of the monthly quoted amount in a single contract during the last three financial years;

b) **Scan copies of following documents shall have to be uploaded by each bidder at the time of online submission of Bids duly signed digitally at desired location in the website <https://wbtenders.gov.in>**

- (i) PAN card,
- (ii) Profession Tax Enrolment and Registration Certificate,
- (iii) PF and ESI Registration Certificate,
- (iv) Income Tax Return for last three Financial Years,
- (v) Audited Balance Sheet and Profit & Loss Account for last three financial years,
- (vi) VAT and VAT Clearance certificate,
- (vii) Proof of credentials along with Work orders issued to the bidder on such work,
- (viii) Payment certificate issued to the bidder for the aforesaid works,
- (ix) Partnership Deed (in case of a firm)/Certificate of Registration (in case of a Company),
- (x) Trade license of the firm / company.

c) Scanned Copy of One affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty, damages, debarment etc. (if any) faced by the bidder during the last three financial years.

d) In case of any litigation or in the event of any default arising during the execution / contract period of the agreement, the lead partner of the firm or the Managing Director of the Company will remain fully responsible.

e) **Earnest Money:** The bidder shall have to deposit the Earnest Money electronically online by using his / her net banking enabled bank account, maintained at any bank. The intending bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the beneficiary name and account no., amount, beneficiary bank name, IFSC Code by mentioning the e-Tender Reference No. All intending Bidders have to deposit Earnest Money Deposit (EMD) for Rs. 20,000/- (Rupees twenty thousand only).

Submission of EMD should be made in favour of West Bengal Infrastructure Development Finance Corporation Limited, only through NEFT / Net Banking to Account of West Bengal Infrastructure Development Finance Corporation Limited, with Punjab National Bank, Brabourne Road Branch on or before 11.00 hrs of 15.06.2017. **EMD in the form of DD / PO shall not be accepted.** Bidders should take utmost care to ensure that the EMD and intimation are made correctly. EMD deposited elsewhere will not be considered for participation in this e-auction. No interest will be payable on the EMD. EMD of the unsuccessful bidders would be returned by WBIDFC Ltd. after a fortnight from the completion of bidding process i.e. awarding to the selected bidder.

There is no Exemption for EMD for the above mentioned Tender. Bidders please note the same.

7. Language of Tender: The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

8. Duration of Service:

The work will remain valid for a period of 6 (six) months from the date of issue of the work order and further renewal of the work will be the absolute discretion of WBIDFC Ltd.

9. Service Fees:

The quotationer will quote the rate for providing such services for a period of six months on the basis of **monthly billing** value with effect from the date of work order as per scope of work in INR including all applicable taxes (if any). Applicable TDS will also be deducted from each & every monthly bills.

10. Statutory Compliances:

- a) The service Provider submits and assures the Company that by virtue of the clauses in Memorandum and Articles of Association of the Service Provider, the Service Provider is authorized to provide "services which are within the scope of this agreement."
- b) The service Provider further represents that it was obtained and possess the necessary statutory registration, licenses, permissions; authorizations whatever the case may be, for providing services which covers this agreement fully and if required shall be produced before the company.
- c) The service provider possess all necessary certificates of employee provident funds, insurance clearance, professional tax clearance and all others statutory clearances.



- d) You are also requested to submit a detailed report on the statutory compliances (including minimum wage stipulations of GOWB) and computation thereof with particular reference to following areas:
- i) Payment of Minimum Wages according to the provisions of the Govt. of West Bengal.
 - ii) Contribution on account of E.P.F, as per related Act and Rules.
 - iii) Contribution on account of E.S.I, as per related Act and Rules.
 - iv) Payment of Bonus, as per related Act and Rules.
 - v) Any other statutory provisions.

The service provider will be solely and exclusively responsible for payment of salaries and other monetary, statutory/non statutory, non-monetary benefits attached to the contract of employment which the deputies have with the Service Provider.

11. Others: The Tender Notice along with other documents like Terms and conditions, Financial Bid (BOQ) etc. whatever documents uploaded by the Department concern shall be part and parcel of the Tender.
